## Airport opening hours and services

- Lappeenranta Airport has no fixed opening hours, seasonal opening hours notified in NOTAMs.

- Scheduled traffic and charter flights will be served upon 21 day prior notice.
- Other openings of the airport can be agreed upon request.

- Lappeenranta offers full ATC service.
- Private flights under VFR/IFR conditions free of charge if ATC is not operational, Ground Handling & parking charges apply if needed.
- All winter operations to be confirmed separately (VFR/IFR)
- Fire & Rescue category FFC 5/7 available on request.
- Cancellation of the flight less than 48 hours will be charged at 100 per cent of the above rates.
- 50 % Surcharge is applicable on Saturdays, Sundays and national holidays and weekdays between 10pm. and 6am.

## 1. Traffic Charges

### 1.1. Landing Charges for scheduled and non-scheduled traffic

Landing charges will be charged on arriving aircraft.

### 1.2. Terminal Navigation Charges for scheduled and non-scheduled traffic

### 1.3. Passenger Charges

Security charges, per person	€ 4,60

Passengers with reduced mobility (PRM), per person	€ 0,40

Passenger and Security Charges, PRM and Government tax will be charged on departing passengers (excluding infants under 2 year olds).

### 1.4. Other charges and services

- Parking charge, restricted availability, each starting 24 hour period: 20 € + 2 € per 1 MTOW-ton, first 2 hours free of charge
- Fuel provider Shell Aviation with separate agreement with Shell. Contacts below.
- Additional hours after first 1 hour of planned arrival or departure EUR 500.-/hour in case of delay every starting hour.
- Arrangement of special operations, where airport standard security or passenger handling procedures are required alterations, all costs are subject to 50 per cent surcharge on all costs subject to that operation.





### 1.5. Extra openings: Ad-hoc Business jets, taxi flights and medical flights

- Single flights that can be considered as ad-hoc with maximum 10 pax are offered fares as stated below. These prices include extra ATC tower opening according to your schedule, landing fee, terminal navigation, parking, airport maintenance, basic ground handling and fire and rescue service according to the FIRE CAT needed. Additional services will be charged according to airport terms of service.
- 50 % Surcharge is applicable on Saturdays, Sundays and national holidays and weekdays between 10 pm. and 6 am.
- Surcharge percentages are always calculated from the \*Basic total charge for operation.
- One operation fare is priced according to the following table dependent on confirmation of the flight including 1 hour delay in planned operation (arrival or departure). Scheduled turnaround within one hour is considered as one operation.
- Additional hours after first 1 hour of scheduled arrival or departure costs +EUR 500/hour in case of delay every starting hour.
- The charge for extended operating hours is +EUR 500/hour every starting hour unless otherwise agreed with the airport for a special reason. Extended operating hours must always be specifically agreed with the airport. If airport operating hours are extended on request due to change of originally requested and confirmed schedule or in the event of delay to provide air navigation, airport maintenance and rescue services for a landing or departing aircraft, an hourly charge for the extended hours of operation is collected for each aircraft for which the service was used.

- If a confirmed operation is cancelled less than 48 hours before the operation the flight will be fully charged according to the above mentioned fares.
- Airport holds right not to confirm operations that are requested less than 72 hours of planned flight.





## 2. Lappeenranta Airport Ground Handling services and charges

Unless otherwise specified, all services comply with IATA SGHA 2023.

Lappeenranta Airport Ltd provides competitive ground handling services using own, experienced staff. Ground handling package includes passenger services, border and customs arrangements, check-in services and boarding, ramp services, aircraft and baggage handling.

In the event of limited GH needs of the operator a general charge of 300 Euros will be charged regardless of aircraft size.
